1. **DESIRE** : I want to sign-on to be a Music International Franchise.
2. **TEACH** : Mainly teach music at least ONE or more of guitar, keyboard, sing or other instrument correctly and properly. You must own THIS instrument.
3. **LEARNING & SUPPORT** : We will help you TOTALLY. With our online subscription, 24x7x365 support, Teach Syllabus, Career growth objectives, Performance, Recordings Monday-Training Programme etc. your personal music development opportunities are limitless.
4. **FOCUS** : You can also select whether you teach, technique, group, lead, rhythm, bass, theory, gospel, sacred, hymns, country, reggae, rock, blues, jazz, salsa, samba etc. Selecting a STYLE-GENRE allows you to have a unique identity and develop your expertise.
5. **PLACE** : You must have place at your home for at least one student at a time. More if possible. You must have a laptop or PC with multimedia Speakers + broadband connection - all of reasonable quality.
6. **TERRITORY** : Starting with Bangalore; we divide a city/town into 3x3x3 matrix of 81 geographical zones. Population, Genre-select also comes into play. Student-transfer based on Timings, Teacher, Instrument, Location may take-place - however we will try to ensure exclusivity on this basis.
